# CONCEPT NOTE

#### SUBMISSION GUIDELINES


#### **ABSTRACT**

- 1. The abstract shall not exceed 300 words.
- 2.It should include the title of the paper, keywords, the presenter's name, designation, institutional affiliation, mailing address, contact number and Email ID
- 3..The abstract should be typed in Times New Roman, font size 12 with 1.5 line spacing.
- 4. Kindly mention the title of the abstract along with details of co-author (if any).
- 5.The abstract shall be sent to knowledgesteezconference@gmail.com with the subject line"Abstract National Conference".
- 6. All submissions should be sent in .doc/.docx format only.

#### FULL PAPER

- 1. The length of full paper including tables, diagrams, illustrations, references, etc. should be 2500-8000 words.
- 2. The paper should be typed in Times New Roman, font size 12 with 1.5 line spacing. The footnotes must be typed in Times New Roman, font size 10 with single spacing. The margin of 1 inch on all sides must be maintained throughout the paper.
- 3. Bluebook 20th Edition/APA shall be strictly followed for Footnoting and referencing.
- 4. The full paper should be submitted in soft copy and shall be sent to knowledgesteezconference@gmail.com with the subject line "Full Paper International Conference" along with the certificate of originality duly filled by the presenter(s).
- 5. All submissions should be sent in .doc/.docx format only.
